

## **Undertaking and Declaration**

In consideration of the Government of the Hong Kong Special Administrative Region of the People's Republic of China ("**Government**") as represented by the Health Bureau, considering and/or approving this application for enrolment in the Chronic Disease Co-Care Pilot Scheme ("**CDCC Pilot Scheme**"), I, the applicant, acknowledge, confirm, undertake, warrant, declare and agree with the following:

- (a) I have carefully read and fully understood the terms and conditions set out in the Transaction Documents (including but not limited to this Undertaking and Declaration) (as defined in Clause 1 of the "Chronic Disease Co-Care Pilot Scheme Terms and Conditions of Agreement for Private Doctors" ("**T&C**"));
- (b) I am eligible to apply for enrolment in the CDCC Pilot Scheme;
- (c) I shall submit to the Government such other information and documents as the Government may require from time to time in relation to my application for enrolment. My application may not be processed by the Government if I fail to provide all information and documents required by the Government;
- (d) all undertaking, warranty, declaration, information and documents provided by me to the Government in my application for enrolment or in relation to the CDCC Pilot Scheme are and will be up-to-date, true, accurate and complete in all respects at the time of provision. If any undertaking, warranty, declaration, information or document is not up-to-date, true, accurate or complete or if I fail to comply with any provision of this Undertaking and Declaration, without prejudice to any powers, rights, remedies and claims that the Government may have under this Undertaking and Declaration or in law, the Government shall be entitled to reject my application immediately or immediately cancel my enrolment if my application has already been approved;
- (e) I have not withheld, nor am I aware of, any material facts or circumstances that have not been disclosed to the Government which may influence the assessment of my application for enrolment or the decision of the Government in considering whether or not to approve my application for enrolment;
- (f) any non-disclosure or misrepresentation of any information required or provided in connection with my application shall entitle the Government to reject my application;

- (g) the Government, any of its agents or officers, and any others persons authorised by the Government shall have full access to and transfer and use my personal data provided in relation to the CDCC Pilot Scheme for the purposes set out in the Personal Information Collection Statement. The word “use” shall have the meaning given to it under the Personal Data (Privacy) Ordinance (Cap. 486 of the laws of Hong Kong);
- (h) this Undertaking and Declaration shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People’s Republic of China and I shall irrevocably submit to the exclusive jurisdiction of the Courts of the Hong Kong Special Administrative Region of the People’s Republic of China;
- (i) notwithstanding any provision hereof, the Government retains the ultimate discretion to approve, reject, withhold or cancel any application submitted by me; and
- (j) until my application is rejected by the Government, or upon my successful enrolment and until I cease to be an enrolled Private Doctor (as defined in Clause 1 of the T&C), I shall comply at all times with all the terms and conditions of the Transaction Documents.
